**Kilgore College Science Investigation Summer Day Camp is a camp for talented 8<sup>th</sup> and 9<sup>th</sup> graders to participate and learn the use of Chemistry and Biology Labs for forensic purposes. Students will be exposed to graphic items that may be found at a crime scene.**

*There will be no actual blood or any other harmful substances at the mock crime scene. The labs will involve experiments such as DNA sampling and testing and other labs that may include exercises that are not usually done in a typical 8th and 9th grade classroom or lab. Students will be fingerprinted. We may feature videos or slide shows that pertain to forensics (similar to what you see on TV for Crime Scene Investigation shows). Our guest speaker is a police officer with the Longview Police Department and he may include safety issues as well as the study of forensics.*

The above-named student ("Student") wishes to attend and participate in the Kilgore College Science Investigation Summer Day Camp ("KCSI"). I understand that KCSI may involve the activities set forth above including but not limited to mock crime scene investigation, laboratory experiments, and audio/video presentations regarding crime scene investigations. I understand further that local media, including radio, newspaper or television, may wish to record or photograph participants in KCSI.

1. I hereby grant permission for my Student to attend and participate in KCSI.
2. In the case of injury to my Student, I hereby grant permission for the Program Administrator, to take steps reasonably necessary to obtain emergency care, if warranted. The steps may include but are not limited to the following:
  - a. Attempt to contact Parent/Guardian at the number(s) provided below.
  - b. Attempt to contact person listed on application as EMERGENCY contact or alternate at the number(s) provided.
  - c. Contact the Kilgore College Police Department or Emergency Services (911).
  - d. Provide emergency medical care and transport to a hospital or clinic, if necessary.

# KCSI LAB & CLASSROOM SAFETY CONTRACT

You will be issued a name badge on our first day and **MUST** wear it at all times while on the campus.

Participation in lab is a privilege! Students are expected to act responsibly. Consequently, any misbehavior or failure to follow directions and safety rules may result in the student's removal from the camp. Students will not be able to participate in labs unless this form is signed and in the Camp Administrator's possession.

## LAB & CLASSROOM RULES:

1. No unsupervised work is allowed in labs at anytime.
2. Students may not enter storage areas or other classrooms without express permission of instructors.
3. Students are not allowed to remove anything from the classroom or lab without permission of the instructors.
4. **DO NOT PLAY AROUND WITH THE EQUIPMENT. NO HORSEPLAY ALLOWED AT ALL.**
5. Safety goggles **MUST** be worn when indicated by the instructor. **ABSOLUTELY NO EXCEPTIONS.**
6. Read all lab instructions before beginning any experiment and take care to avoid causing accidents by sudden movements or inattention to the experiment. Listen carefully to directions.
7. Dress appropriately for labs. **NO open-toed shoes allowed in labs.** Care should be taken to keep hair and clothing from heat or flames.
8. Your lab space should be clean when finished with the experiment.
9. Never taste chemicals or put your hands in your mouths while handling lab materials. Wash hands thoroughly after every lab.
10. Follow the instructor's directions for disposal of all waste materials and chemicals.
11. Inform the instructor immediately of any accidents, spills, or incidents that occur. Chemical spills or broken glass will be cleaned up by instructors only.
12. You may not "roam" the campus unattended at any time. You must be accompanied by a camp instructor.
13. You must try to be quiet in the hallways of the campus, other classes are being held.
14. Do not bring your toys, games, gadgets, from home. (They could be stolen or broken.)
15. We have a zero tolerance policy for alcohol, drugs, or tobacco products.

**Arrival · Drop-off Location:** Engineering Science building Room 317 (see map for location). Parent/Guardian escorts student to registration in the Engineering Science building on the first day. For following days, parent/guardian may drop students off and students may proceed to ES 317.

**Arrival Time:** Drop off your student between **8:45 a.m-9:00 a.m.** daily. We officially begin classes & labs at 9:00 a.m.

**Departure · Pick-up Location:** Engineering Science building (see map for location). Students must be picked up by a designated parent/guardian and will not be released to anyone who is not authorized. To obtain permission for an alternate pick-up, parents/guardians must provide written authorization.

**Departure Time:** Pick up your student promptly at **1:00 p.m.**

**Name Badges & Walking Around the Kilgore College Campus Facilities:** While at the KCSI Summer Day Camp at Kilgore College, you **MUST** wear your lanyard KCSI name badge at all times. Students may not roam the campus unattended at any time. All students must be accompanied by KCSI Summer Day Camp Staff or Kilgore College Officials, or parents/guardians to walk to other buildings or activities on campus.

**Personal Belongings:** Personal belongings are the student's responsibility. KCSI Summer Day Camp and Kilgore College will not be responsible for lost or stolen items. Do not bring games, gadgets, or electronic items from home.

**Cell Phones:** Use of cell phones or electronic communication devices during lectures, classes, and labs is strictly prohibited.

**Dress Code:** Dress appropriately for labs (you may bring a lab coat if you have one). Some experiments may be messy. We strongly recommend that students leave their rings/bracelets/jewelry at home. **NO open-toed shoes allowed in labs.** Long hair should be tied back or secured while in labs.
