Testing is administered on a first-come, first-served basis with LIMITED seating for each session. Candidates are **strongly** encouraged to apply and register early. Once sessions are filled, candidates will need to schedule testing at an authorized Pearson VUE test center by visiting www.pearsonvue.com or by calling 1-800- 292-2273.

Registration procedures:

1. Registration must be done either in person or by fax and payment must be made by calling the Cashier's Office at 903-983-8108 when form is faxed. **Mailed registration forms will not be accepted.**
2. Candidates must be applying to the KC Nursing Program and should submit the nursing application prior to testing
3. The \$50 testing fee must be paid to the Cashier's office by cash, credit card or money order prior to registering for the test and **testing fees are NON-REFUNDABLE-No exceptions**

Testing Guidelines

1. Photo Identification is required
2. Candidates should arrive at least 10 minutes early to sign in for exam and late examinees will not be admitted
3. Testing is available on a first-come, first-served basis with **limited** seating.
4. Test is timed and usually lasts 2 ½ hrs.
5. Study guide available in KC bookstore
6. Results are available immediately following test
7. 60% required on both Composite Math and Composite Reading Comprehension sections
8. **CELL PHONES AND OTHER CELLULAR AND ELECTRONIC DEVICES ARE STRICTLY PROHIBITED IN TESTING CENTER**
9. Testing accommodation requests must be made through Special Populations Office
10. Applicants must wait 10 days between retests. Retesting may only occur twice within a calendar year.

REQUIREMENTS FOR TAKING THE NET EXAM

Must be applying to the **KC Associate Degree Nursing (R.N.) Program**

WHEN AND WHERE TO TAKE THE NET

The test is administered in the Testing Center, located in Kilgore on the second floor of the Devall Student Center according to a predetermined schedule, **on a first-come, first-served basis with LIMITED seating for each session.**

TEST CONTENT

The NET is administered on the computer and consists of seven parts: Reading Comprehension, Essential Math Skills, Reading Rate, Test-taking Skills, Social Interaction Profile, Stress Level Profile, and Learning Style. Calculators and scratch paper will be provided.

LENGTH OF EXAM

The NET exam is timed electronically and usually lasts 2 ½ hours.

EXAM COST

The test fee is \$50.00 and is **non-refundable.** Testing fees are to be paid in the Cashier's Office, located on the 1st floor of the Devall Student Center in Kilgore, by cash, credit card or money order only **prior to signing up in the Testing Center.**

STUDY GUIDE

The Nurse Entrance Test Study Guide, is available for purchase, in the KC bookstore.

TEST RESULTS

Results of the NET appear as soon as the exam is finished. Candidates will be given a copy of his/her scores immediately following test administration.

PASSING STANDARDS

60% is required for the **Composite Math Skills** along with a score of 60% on the **Composite Reading Comprehension** section of the test

RETESTING GUIDELINES

Candidates may test only twice in a calendar year including retests and must wait at least 10 days between tests.

GENERAL TESTING INFORMATION

- *All candidates must present photo identification upon each visit to the testing center.*
- *Cell phones and other cellular devices are strictly prohibited in the testing center. If brought, these items will be placed in secure locker cabinets and will be returned to the candidate upon dismissal from the center.*
- *Candidates should arrive for testing at least 15 minutes early. Late examinees will not be tested.*
- *Students may use only the scratch paper provided by testing staff.*
- *Test accommodation requests must be made by contacting the Special Populations Office*
