The City of Big Spring Fire Department is currently accepting applications to establish an eligibility list for Certified Firefighter/EMTs. Minimum qualifications are as follows.

For consideration as a CERTIFIED applicant, applicants must have the following certifications:

- A valid basic structural firefighter certification from the Texas Commission on Fire Protection (TCFP) (https://www.tcfp.state.tx.us/standards/certification/certification_lookup.asp) **AND**
- An Emergency Medical Technician (EMT) basic or higher certificate issued by the Texas Department of State Health Services (DSHS) (<http://dshsregn.dshs.state.tx.us/ems/certquery.htm>).
- High School diploma or GED equivalency certificate.
- Must have reached at least eighteen (18) years of age as of the date of the written test and not have reached thirty-six (36) years of age as of the date of appointment.
- Must possess a valid state issued driver's license and, on date of hire or within three (3) months of date of hire, must have obtained a Commercial Texas Driver's License, either a Class A or Class B, for the type of vehicle or equipment operated.
- Certified applicants must satisfactorily complete the physical agility course set out by the department in one (1) attempt.
- Must pass a comprehensive background investigation and not have any of the disqualifiers established by the department.
- If applicable, you must submit a Form DD-214-4 (long form) to verify an honorable or general discharge under honorable conditions from the military.

The eligibility list will consist of certified and non-certified candidates who successfully complete the written Civil Service entrance examination and the physical agility test. The eligibility list shall be in effect for one (1) year from the date of the examination, until May 14, 2022, unless exhausted earlier. The City Manager will make initial appointments from the current eligibility list.
