When referring to websites on bibliography page, one must state "Retrieved from" and then the website with no access date or period.

According to Jones, “Students often had difficulty using APA style” (199), so teachers should use this to inform their instruction.

One expert says, “Students often have trouble using APA style” (Jones 199), but she did not offer an explanation as to why.

NOTE: The APA makes the page number for a paraphrase optional, but we recommend using the page number in both paraphrases and direct quotes.
