Tenant shall, during the entire Term of this Lease, procure and keep in full force and effect, a general liability policy that covers the leased Premises, in which the limits of liability shall not be less than a single limit of \$100,000.00 per occurrence | \$300,000.00 general aggregate. The policy shall name Landlord as an additional insured, and shall contain a clause that the insurer will not cancel or change the insurance without first giving the Landlord ten (10) days' prior written notice. A Certificate of Insurance shall be delivered to Landlord upon execution of this Lease Agreement.
6. New Property – Kilgore College has these projects in progress and will need to add at time of completion
 - a. Pedestrian Bridge - \$4,483,000 (owned by Kilgore College)
 - b. CDL Training Track - \$1,700,000 (owned by Kilgore College)
 - c. Regional Medical Center (Leased Facility from City of Kilgore) – Est \$6,000,000

LESSEE'S INSURANCE-LESSEE shall procure and maintain, during the TERM of this Lease and any renewals and extensions thereof, at its sole cost and expense the following which may be one or more policies: a liability policy or policies of insurance in the face value of at least \$1,000,000.00, insuring LESSEE as well as LESSOR from all claims, demands, or actions arising out of LESSEE'S use and occupancy of the LEASED PREMISES, including LESSEE'S Indemnity of LESSOR below, and fire and casualty insurance in an amount sufficient to replace LEASED PREMISES. LESSEE shall provide LESSOR with a certificate naming LESSOR as an additional insured under the liability insurance policy, and further providing that the policies required herein cannot be canceled without 30 days' notice to LESSOR. LESSEE shall provide LESSOR with proof of fire and casualty insurance annually. If LESSEE should fail to maintain any such insurance, LESSOR may purchase such insurance, and add the cost of any premiums to LESSEE'S annual RENT.
