Federal student aid programs are based on the principle that students and their families should be the primary source of support for college education. A student who does not meet any of the criteria listed under Step 3 of the FAFSA is considered a dependent student and must provide parent financial information. Under certain unusual circumstances a financial aid office can override a student's dependency status.

Circumstances considered for granting a dependency override:

- Student's removal from parent's home due to situation that threatened the student's health or safety.
- Incapacity of parents to provide information due to medical condition or inability to be contacted.
- Other extreme circumstances that can be sufficiently documented. Examples of documentation to attach, as applicable to the situation: Legal documentation such as arrest, court papers, Child Protective Services records, correctional facility records/incarceration reports.
- Medical documentation such as death certificate, hospital records, reports of institutionalization.
- Statement regarding knowledge of your parental situation from an unrelated professional such as a school official, minister, social worker, physician, lawyer, law enforcement officer, superviosr. Statement should include the person's full name, title or position, phone number and signature.
- Student is self-supporting and can document self-sufficiency (lease and one utility bill in student's name) and at risk for homelessness.

## \*\*\*\*Circumstances that are NOT grounds for a dependency status change\*\*\*\*\*

- Student has ongoing disagreements with parents
- Parent does not claim student for income tax purposes
- Parent does not contribute to student's education
- Parent/ step-parent refuses to provide information for FAFSA or for verification: student will be eligible for the Federal Unsubsidized Student loan only!
