Dear Applicant:

Thank you for your interest in the Diagnostic Medical Sonography program (DMS). The DMS program is a 21-month full-time program including both didactic classes, laboratory and clinical experiences. This information packet includes the admission requirements, the point system for selection, the curriculum, and information to help you through the application process.

Upon completion of the provided curriculum, students will graduate with an **Associate's Degree in Diagnostic Medical Sonography (A.A.S.)**. Students graduating from this program will be eligible to sit for the registry examination administered by **The American Registry of Radiologic Technologists (ARRT)** in Sonography. *Pending other accreditation standards and best practices.*

Kilgore College is an open admissions college; however, acceptance into the Diagnostic Medical Sonography (DMS) program is limited and highly competitive. There is a limited number of applicants admitted to this program. To be considered for admission for the Fall Class (Cohort 2026), all required application materials must be submitted by the deadline stated in this application. Students are accepted based on a structured criteria and point system. The point system will determine admission decisions.

## Technical Performance Standards for a Diagnostic Medical Sonographer

### Essential Job Responsibilities & Technical Standards:

Technical standards are a group of minimum expectations that incorporate observation, communication, and cognitive, behavioral, and motor skills, as recommended by the Society of Diagnostic Medical Sonography. These expectations are set forth so that the DMS student can perform the common duties required of a Sonographer in a professional setting. Students must verify that they meet the technical standards described below at the time of matriculation into the program. In addition, students accepted to the DMS Program must notify the DMS Program Director immediately if there is a change in their ability to meet any required technical standards.

#### Observation

- Distinguish multiple shades of gray to differentiate types of tissue and normal tissue from abnormal pathologies.
- Detect different colors to distinguish tissue, organ boundaries, and/or Doppler flow patterns.
- Observe sonographers demonstrating scanning skills, patient manipulations, and delivering effective patient care.
- Observe patients for signs of distress and/or to detect needs for assistance both near and far in an environment with limited lighting.
- Have the visual ability to read electronic and paper charts, evaluate images, and observe the condition of the patient.
- Adequately view sonograms and be able to perceive small details as well as to discriminate subtle differences in tissue, sounds, and/or blood flow dynamics.

#### Communication

- Communicate effectively to the patient and professionals in the facility assigned
- Hear and communicate instructions and explanations to patients and/or caregivers clearly and compassionately and be able to perceive nonverbal communication.
- Recognize, respond, and communicate properly when faced with an urgent or emergency situation.
- Read and analyze a patient chart and exam requisition(s) for pertinent information.

#### Cognitive Abilities

- Implement critical thinking skills in clinical and lab settings.
- Demonstrate problem-solving skills by recognizing problems, instituting solutions, and assessing outcomes.
- Integrate, analyze, and compare information based on ultrasound images.
- Comprehend multidimensional and spatial relationships of anatomy.
- Perform quantitative and qualitative analysis when problem-solving.

#### Behavior

- Be organized and perform protocols in a specific sequence.
- Learn by a variety of methods, including classroom, lab, groups, individual, and computer activities.



- Display professional behaviors in all interactions with patients, caregivers, students, healthcare workers, and instructors in clinical, lab, and college settings.
- Adapt to changing environments.
- Accept constructive feedback from others and implement changes learned from feedback.
- Understand the implications of noncompliance with the legal standards.
- Maintain good judgment to complete responsibilities as required.

### **Motor Skills/Physical**

- Be able to bend or stoop for equipment manipulation repetitively.
- Be able to lift 50 lbs. routinely.
- Stand for long periods of time, up to 80%.
- Push or pull large pieces of equipment up to 500 lbs.
- Have full use of hands, wrists, and shoulders for scanning and equipment manipulation.
- Manipulate equipment controls in various increments to create diagnostic images.
- Bend at the waist.
- Reach equipment keyboard, controls, and screen.
- Maintain arm and hand positions for extended periods of time for various scanning protocols.
- Have good hand and eye coordination for accurate examination of organs and document images.

The profession requires clinical judgment and the ability to provide appropriate health care services. Sonographers are highly skilled professionals qualified by technological education to provide patient services using diagnostic ultrasound under the supervision of a Doctor of Medicine or Osteopathy. The sonographer may provide this service in a variety of medical settings where the physician is responsible for the use and interpretation of ultrasound procedures. Sonographers assist physicians in gathering sonographic data necessary to reach diagnostic decisions.

A balanced curriculum of general didactic and clinical courses offers the student an opportunity for cultural development as well as occupational competence. Clinical instruction is given at area hospitals and clinics. Once accepted into the program, the student will be assigned to a clinical education site.

## Admission Requirements

**May 21, 2026 – Admissions Application Deadline for DMS Applicants**

### 1. Application for Kilgore College Admission

### 2. Transcripts

**One** official transcript must be sent directly to the KC Admissions office **and** one to the **DMS Program Director** with the application packet from issuing schools/agencies. College transfer students must submit official transcripts from all colleges in which they have enrolled.

### 3. Prerequisites

All applicants must show completion of prerequisite courses by **May 21, 2026**. All prerequisites must be completed with a grade of “C” or greater. (Any course substitution must be approved by the DMS program director). **Points earned: A=4 B=3 C=2**

### 4. Interview Due Process

The top 20 eligible applicants will be interviewed. The interview will be conducted by the DMS Interview Committee for the applicant only on **June 20, 2026**.

### 5. Sonography Shadowing Hours (mandatory)

Students are required to shadow in a sonography department for eight (8) hours with a credentialed sonographer. Modalities of Abdomen and OB/Gyn (must be a combination of both). Documentation is mandatory and found in this packet. The evaluation must be signed and submitted with this packet. The DMS program will not assist in finding a facility for shadowing.

### 6. Healthcare Certification (bonus)



Applicants are given three (3) bonus points for health care certifications. A copy of the credentials must be included in the packet. The following are examples, but not limited to: LPN, RN, MLT, MA, NA, PCT, etc. For additional questions, contact the program director.

#### 7. **Additional Points for Applicants**

- **Cumulative GPA** (average of all prerequisite courses)
- **Previous Applicant:** 3 points
- **Academic Degree Points:** Associates = 3, Bachelor's = 4, Masters= 5, Doctorate =6

#### 8. **Background Check and Drug Screening**

**Accepted** students in the DMS program will be required to undergo a criminal background check and drug screen prior to the beginning of the program. This procedure is conducted after a student has been accepted to the program. Additional information will be provided at the DMS mandatory orientation. This will be at the student's expense.

#### **Additional Notes**

- A CPR card from the American Red Cross or American Heart Association must be submitted by August 3<sup>rd</sup> once accepted into the DMS program
- Further information will be provided for those with completed applications during the DMS orientation.
- Students who are accepted into the DMS program will be notified via phone call the week following interviews (additional documentation will be emailed to the student's KC email)
- If you have been enrolled, dropped, and or dismissed from another DMS program or **any** Allied Health Science program(s) a mandatory meeting with the Program Director is required.

## Application Due Process

For the applicant selected for tentative placement into the Diagnostic Medical Sonography program, the following will occur:

### The Applicant:

- Will receive a letter of notification and Kilgore College Health Forms by **June 23, 2026**
- Must submit a written acceptance of placement to the Program Director by **June 25, 2026**.
- Will be required to return all health forms: physician's examination, a full release signed by a health care provider; immunization records, background, and drug screening results.
- The deadline for returning the above completed health forms is **August 1, 2026**. Failure to submit all required forms by the deadline will result in forfeiture of placement.
- A copy of the CPR card, deadline is **August 3, 2026**
- All accepted students must maintain a "C" (75) or better in all required DMS courses. A final grade of "F" constitutes failure to pass, and dismissal will occur.

## Frequently Asked Questions

### How long is the DMS Program?

The DMS program is 21 months post completion of prerequisite courses. The DMS program is five consecutive semesters, beginning every Fall semester with a combination of coursework, lab, and clinical.

### Is the program accredited?

Not at this time, however, Standards and Best Practices are in place for future accreditation.

### What are the steps to apply to the DMS Program?

Once all prerequisite courses are completed with a “C” or better, students are eligible to apply for the program by completing the DMS Application Packet in its entirety.

### What are the prerequisites to qualify for entry to the DMS program?

Students must complete the following classes with a “C” or higher to be considered for entry to the DMS program.

May 15, 2026 - by Midnight  
June 1, 2026 - Interview Top 20 Students - 9 am-Noon  
Aug 3, 2026 - Orientation for Selected Applicants – 8:30 am

**How many students are accepted into the program?**

10 candidates will be admitted for the Fall 2026 start.

**When and how do I complete my background checks/drug screening?**

Once **conditionally** accepted to the DMS program, you will receive instructions from the program director on how and when to complete these background checks. **Must pass** to maintain acceptance.

**What is considered a passing grade in a DMS course?**

75% (C) or higher is a passing grade in all the DMS-specific courses.

**Who is responsible for setting up clinical experiences/rotations?**

It is the program director and clinical coordinator's responsibility to place all students at clinical sites each semester.

**Is transportation provided to and from the clinical sites?**

No, students are responsible for their own transportation.

**Will my previous college coursework/classes transfer to KC?**

Official transcripts must be submitted to KC Admissions. The Registrar will review the transcripts for transfer eligibility. Courses must be from an accredited college and /or university.

**Are the classes in person or online?**

Most didactic classes and labs will be held in person, Mon-Fri between 8:00 am-4:30 pm. Some classes may be hybrid.

**Will I be able to work while enrolled?**

Working is not recommended during the program; however, that is the discretion of the student.  
*Please note: This is a full-time program.*



**Am I required to wear a uniform, and who provides it?**

Students are expected to wear specific scrubs in the lab and at clinical. This is the responsibility of the student. More information is provided at orientation for accepted students.

**How can I get information about tuition, scholarships, and financial aid?**

The KC business office and financial aid office are available to answer specific questions regarding tuition, financial aid, and withdrawal policies. Academic advisors, student services, and visiting the KC website frequently for updated scholarship information is recommended. [ADMISSIONS](#)
